

# *Small Business Digital Account*

## *Fee-free Offer 2025 Terms and Conditions*

### **1 Definitions**

1.1 In these Terms and Conditions the following definitions are used:

- 1.1.1 **"Business Account Fee Brochure"** means our 'Fees and Service Charges explained' brochure available here: [danskebank.co.uk/busdocs](https://danskebank.co.uk/busdocs)
- 1.1.2 **"District"** means our internet-based office-banking system for business customers.
- 1.1.3 **"Fee-free"** means the disapplication of our Transaction and Maintenance Fees and Service Charges, as more particularly outlined at clause 3.
- 1.1.4 **"Offer"** means the Fee-free Small Business Digital Account offer.
- 1.1.5 **"Offer Period"** means the period which is 24 months from the date of account opening.
- 1.1.6 **"Business Account Terms and Conditions"** means our general terms and conditions for business accounts available here: [danskebank.co.uk/busdocs](https://danskebank.co.uk/busdocs)

### **2 Eligibility**

2.1 To qualify for the Offer, you must:

- 2.1.1 be a new Danske Bank Business Current Account customer;
- 2.1.2 be a sole trader, partnership, limited company, limited partnership, or a limited liability partnership;
- 2.1.3 be a business registered in Northern Ireland and with a trading address in Northern Ireland;
- 2.1.4 register for District on account opening;
- 2.1.5 select a Mastercard Business Debit Card on account opening;
- 2.1.6 have a maximum Business Turnover of £1 million per annum;
- 2.1.7 not make any single cash lodgements at counter/cash drop with a value of £5,000 or more; and
- 2.1.8 not make any cash lodgements at counter/cash drop where the total amount lodged is £150,000 or more in any rolling 6-month period.

### 3 Fees

3.1 Details of our fees and service charges payable from time to time can be found in our Business Account Fee Brochure.

3.2 Subject to the Business Account Terms and Conditions we'll always give you at least 60 days' notice of any changes to our fees and service charges that will apply to your account before you start to incur charges.

3.3 Subject to the provisions of clause 2 (Eligibility), for the duration of the Offer Period no fee will be applied in respect of our Transaction and Maintenance Fees and Service Charges, as outlined in the table below:

3.5 At the end of the Offer Period, you will be charged our standard Transaction and Maintenance Fees and Service Charges payable from time to time in accordance with our Business Account Fee Brochure.

3.6 We'll contact you 60 days before the end of the Offer Period to notify you that the Offer is coming to an end.

## 4 *Withdrawal of the Offer:*

- 4.2 Applications received after any final application date will not be eligible for the Offer.
