Conditions of Collection

- The Bank is not liable for loss, damage, or delay however caused, which is not directly due to the negligence, or default of its own officials or servants.
- Where, owing to exchange restrictions, prohibitions, or suspensions of means to effect transmission, payment of a bill is effected in a currency other than that which it is drawn, neither this Bank nor its agents can accept responsibility for any loss in exchange which may occur if and when subsequent conversion shall take place. If the bill is paid in a currency other than the currency of the account number which is to be credited then the Bank will carry out a currency conversion before it credits the account number set out above. If the amount to be converted is greater than the sterling equivalent of £25,000 the Bank may agree a booked rate with you before the conversion takes place, however, the Bank is not obliged to do so. Where a booked rate has not been agreed with you the Bank will advise you of the rate of exchange which it has used once the currency conversion has been completed. In these circumstances, the rate of exchange will always be at least equal to the Danske Bank Exchange Rate (UK).
- We hereby declare that the instructions given comply with the foreign exchange regulations and orders concerning currency conditions and foreign trade that are in force at the time of entering.
- We undertake to reimburse the Bank for all charges incurred in connection with this bill, whether paid or unpaid.
